




Transconductance






On-Resistance vs. Drain Current




**Gate Charge** 






On-Resistance vs. Junction Temperature




**Source Drain Diode Forward Voltage** 




On-Resistance vs. Gate-to-Source Voltage



Threshold Voltage




Drain Source Breakdown vs. Junction Temperature




